The NTCPA was hosted by Baylor Scott and White Health Police Department with training beginning at 10:00 am. President Scott Voigt welcomed everyone and led the Pledge of Allegiance to the American flag. The invocation was offered by Jerry Blevins. Chief Jesse Gomez from Baylor Scott and White Health PD welcomed members of NTCPA. He gave a brief description of his agency and the duties and challenges they face on their multiple campuses. He fielded many questions from the group. The lead instructor, Jim Caauwe, Drug Diversion Officer, introduced the additional instructors, Marty Colvin, Kirk Starr, Sgt. Royalty, and Jerry Blevins. The training topic was "Drug Diversion in a Health Care Setting: What Patrol and Investigators Need to Know". Training concluded at 12:05 pm, followed by a short break for lunch.

The general membership meeting began at 12:20 pm. President Scott Voigt thanked Baylor Scott and White PD for providing the training topic, instructor and location.
