

## **General Meeting Minutes**

November 19, 2020

The General meeting was held via ZOOM. Training began at 10:00 am. There were over 30 participants for the meeting using computers and cell phones. The training topic was "Identity Theft and How To Not Fall Prey". The instructor was Officer Wendy Sheriff from Garland Police Department. President Scott Voigt welcomed members and guests to the training session. Wendy Sheriff briefly explained the process to get TCOLE credit for the course. The training ended at 11:56 am.

The general meeting began at 11:57 am. President Scott Voigt spoke briefly about the continued difficulty finding training locations because of restrictions that are in place for in-person training. He will work with the Board to locate topics and practical ways to provide future training to our members. The TCPA Board has been notified that NTCPA is willing to work to update and develop CP1, CP2, and CP3. There will be no December luncheon this year. We hope there will be ZOOM meeting for our training in March and April 2021. In-person meetings will be re-evaluated in the second quarter of 2021.

1<sup>st</sup> VP Training, Wendy Sheriff stated that currently we are waiting for information from TCPA to update CP1-CP3 for class instructors. She also challenged all current NTCPA members to bring one person to NTCPA meetings and increase our membership numbers. 2<sup>nd</sup> VP Membership, Valerie Snyder advised our current membership has 112 active members plus 1 transfer from Chisolm Trail and 12 lifetime members. Remember to renew your membership before the new year.

3<sup>rd</sup> VP Communications, Mark Brazelton had nothing to report.

Treasurer, Lita Snellgrove advised the balance of the checking account and the savings account balance. The major expenses have been for our ZOOM service and Quickbooks.

Secretary, Leslie Willingham read the General Meeting minutes for Sept. 2020 to Oct. 2020. A motion to accept the minutes as read was made by Lita Snellgrove and seconded by Wendy Sheriff. The motion passed unanimous. Election of NTCPA Board positions were as follows: There were no additional nominations. There were no additional write-in names on absentee ballots received. The membership unanimously elected Scott Voigt -President, Valarie Snyder -2<sup>nd</sup> VP Membership, and Lita Snellgrove- Treasurer.

A motion to adjourn was made by Wendy Sheriff, seconded by Lita Snellgrove, motion passed. The meeting adjourned at 12:18 pm.

On December 26, 2020 a Birthday Car Parade was held at Memorial Stadium to celebrate the 80<sup>th</sup> Birthday of NTCPA member Artie Woods, who is also known Internationally as Mr. McGruff.

On February 18, 2021 the Board had a ZOOM meeting that was rescheduled because of power outages from a record breaking snow storm.


Training for March 2021 was cancelled because of an Ooops. A message from President Scott Voigt was sent to all NTCPA members with important information.
