



General Meeting Minutes

August 18, 2022

The General Meeting was hosted by Flower Mound PD at the Denton County Southwest Courthouse, 200 Canyon Falls Drive, Flower Mound, TX. The training topic was, “Virtual Reality and Community Engagement with AXON”. The instructors were Keith Valentine (Virtual Reality Solutions Specialist), and Matthew Applebaum (Account Executive). The training began at 10:03 am with the Pledge of Allegiance and Texas Pledge of Allegiance led by NTCPA President Scott Voigt.
